## PRESSURE ULCER RATES

Pressure ulcers remain a key indicator of nursing home care quality in the Hudson Valley. Recent data show an average pressure ulcer rate of 9% across regional nursing homes, with facility rates ranging from 0% to as high as 18% – roughly in line with the New York State average (9.6%) but notably higher than the national average of 6.5%.

## AP DRUGGING RATES

Antipsychotic medications are too often used inappropriately in nursing homes. In the Hudson Valley, the average antipsychotic drugging rate is 20.36%, with some facilities reporting rates as high as 64%, raising serious concerns about chemical restraints and the quality of dementia care in the region.

## VACCINATION RATES

Pneumococcal vaccination is a key preventive measure for older adults, yet Hudson Valley nursing homes show striking variation in long-stay vaccination rates – from as low as 24% to full coverage in some facilities – raising concerns about consistency in preventive care.
