Regulation 10 NYCRR 415.12 Quality of Care

(c) **Pressure sores.** Based on the comprehensive assessment of a resident, the facility shall **ensure** that:

- ❑ (1) a resident who *enters the facility without pressure sores* does not develop pressure sores unless the individual's clinical condition demonstrates that they were unavoidable *despite every reasonable effort to prevent them*; and
- ❑ (2) a resident *having pressure sores* receives necessary treatment and services to promote healing, prevent infection and prevent new sores from developing.

PRESSURE ULCERS

Pressure ulcers (also called bed sores) are a red-flag indicator of possible neglect: a facility must ensure that a resident admitted without pressure sores does not develop them unless unavoidable, and if sores do exist, the facility must provide timely treatment, preventive devices, property nutrition, positioning, and incontinence care.

The chart on the right highlights the 20 Hudson Valley nursing homes with the largest gaps between Expected Staffing and Actual Staffing, meaning they provide far fewer nursing-care hours than residents' assessed needs require.
