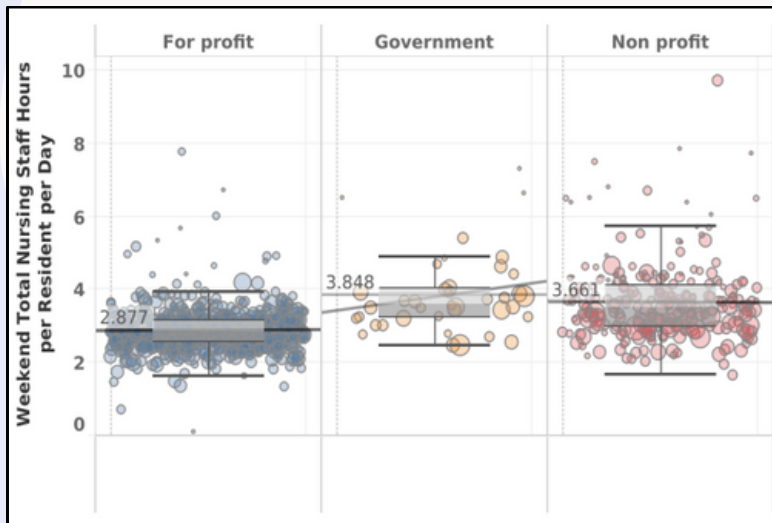

OWNERSHIP MATTERS

For-profit nursing homes have 25% less weekend staffing than government owned facilities and 20% less weekend staffing than non-profit facilities. [See chart on left.] Additionally, for-profit nursing homes have 50% less weekend staffing than government owned facilities and 40% less weekend staffing than non-profit facilities.

MEDICAL DIRECTORS

Federal regulations mandate that all nursing homes have a medical director responsible for overseeing resident medical care and ensuring compliance with care policies. In the Hudson Valley, 42 out of 92 nursing homes reported no medical director presence for Q1 2025.
