





Background on the Requirements for Sufficient Staffing

The Federal Nursing Home Standards: Requirements for Care Staff

Why Are These Rules Important?

- Staffing is critical to nursing home quality and resident safety.
- Too many facilities are understaffed, leading to inadequate care.
- Staff competencies vary, too often failing to meet resident needs.
- Some owners and administrators neglect minimum care standards, including proper staffing.
- Knowledge = Power: Understanding resident rights and accessing key resources strengthen advocacy for better care.

Note: This discussion focuses on the federal requirements for care staff. States can provide additional standards and protections. For example, New York has a quantitative minimum staffing requirement of 3.5 nursing staff hours per resident per day (HPRD).

+ Fundamental Requirements for Care Staff

Nursing Services [42 CFR 483.35 F-725]

The facility must have sufficient nursing staff with the appropriate competencies and skills sets to provide nursing and related services to assure resident safety and attain or maintain the highest practicable physical, mental, and psychosocial well-being of each resident, as determined by resident assessments and individual plans of care and considering the number, acuity and diagnoses of the facility's resident population....

+ Sufficient Staff [42 CFR 483.35(a) F-725]

The facility must provide services by sufficient numbers of each of the following types of personnel on a 24-hour basis to provide nursing care to all residents in accordance with resident care plans:

- (i) ...licensed nurses; and
- (ii) Other nursing personnel, including but not limited to nurse aides.

Notes:

- 1. There are limited circumstances under which the licensed nurse requirement may be waived.
- 2. Many states have additional requirements such as quantitative minimum staffing ratios.

+ Nurse Aide Competency [42 CFR 483.35(d) & (e) F-728]

Proficiency of nurse aides. The facility must ensure that nurse aides are able to demonstrate competency in skills and techniques necessary to care for residents' needs, as identified through resident assessments, and described in the plan of care.

A facility must not use any individual working in the facility as a nurse aide for more than 4 months, on a full-time basis, unless—

- That individual is competent to provide nursing and nursing related services; and
- That individual has completed a training and competency evaluation program, or a competency evaluation program approved by the State...; or
- That individual has been deemed or determined competent [based on long-term experience and other federal requirements]....

Non-permanent employees. A facility must not use on a temporary, per diem, leased, or any basis other than a permanent employee any individual who does not meet the [above] requirements....

"A measurable pattern of knowledge, skills, abilities, behaviors, and other characteristics that an individual needs to perform work roles or occupational functions successfully."

[From CMS Surveyor Training.]

Performance Review & Training of Nurse Aides

I. *Regular in-service education.* [42 CFR 483.35(d)(7) F-730]


The facility must complete a performance review of every nurse aide at least once every 12 months, and must provide regular in-service education based on the outcome of these reviews. In-service training must comply with the requirements of §483.95(g).

II. Required in-service training for nurse aides. [42 CFR 483.95(g) F-947]

In-service training must—

- (1) Be sufficient to ensure the continuing competence of nurse aides, but must be no less than 12 hours per year.
- (2) Include dementia management training and resident abuse prevention training.
- (3) Address areas of weakness as determined in nurse aides' performance reviews and facility assessment... and may address the special needs of residents as determined by the facility staff.
- (4) For nurse aides providing services to individuals with cognitive impairments, also address the care of the cognitively impaired.



+ Requirements for Medical Directors

Medical Director [42 C.F.R. § 483.70(h); F841]

- "Medical director" means a physician who oversees the medical care and other designated care and services in a health care organization or facility. Under these regulations, the medical director is responsible for coordinating medical care and helping to implement and evaluate resident care policies that reflect current professional standards of practice.
- The facility must designate a physician to serve as medical director.
- The medical director is responsible for
 - Implementation of resident care policies; and
 - The coordination of medical care in the facility.
- The facility must identify how the medical director will fulfill their responsibilities to effectively implement resident care policies and coordinate medical care for residents in the facility. Furthermore, the facility must ensure all responsibilities are effectively performed to ensure residents attain or maintain their highest practicable physical, mental, and psychosocial well-being.

Resident Rights: Focus on Family

+

Families, Friends, & Family Councils

Families and friends of residents provide important supports of their resident's well-being and quality of clinical care and other services.

Family councils – which can be created by, and comprised of, both family and friends – can make a big difference in a nursing home's quality of care and quality of life.

Research has shown that the presence of an active family council improves care for ALL residents – even those without a family member on the council.

While the idea of a family council can seem burdensome, being part of a family council can actually RELIEVE BURDEN and maximize the impact of your efforts on behalf of your resident.

Federal Rule

Nursing homes "must protect and promote the rights of each resident," including a resident's right to "organize" and participate in resident groups" and a family's right to "meet in the facility with the families of other residents"

- + Federal standards provide residents and families the following protections
 - The facility must provide a resident or family group, if one exists, with private space; and take reasonable steps, with the approval of the group, to make residents and family members aware of upcoming meetings in a timely manner.
 - Staff, visitors, or other guests may attend resident group or family group meetings only at the respective group's invitation.
 - The facility must provide a designated staff person who is approved by the resident or family group and the facility and who is responsible for providing assistance and responding to written requests that result from group meetings.

- + Federal standards provide residents and families the following protections (continued)
 - The facility must consider the views of a resident or family group and act promptly upon the grievances and recommendations of such groups concerning issues of resident care and life in the facility.
 - The facility must be able to demonstrate their response and rationale for such response.
 - This should not be construed to mean that the facility must implement as recommended every request of the resident or family group.

CONSUMER FACTSHEET: RESIDENT & FAMILY COUNCILS

Resident and Family Councils can play a very important role in improving care and quality of life in a nursing home. However, residents and families can face challenges in respect to organizing and meeting in a way that is independent of the facility staff and enables them to make their voices heard.

The new federal nursing home standards clarify and strengthen requirements for nursing home Resident & Family Councils. Following are relevant provisions in the regulations that you can use to support a vibrant and effective Resident or Family Council in your nursing home.

Please note: (1) Text in italics is directly from the federal regulations. (2) Brackets provide references to the federal regulations and the F-tag number (used when a facility is cited for failing to meet the requirement). (3) These standards are applicable to all residents in licensed nursing homes in the United States, whether they are short-term or long-term, private pay, Medicaid, Medicare or have another type of insurance. (4) Where the resident lacks capacity to make decisions and/or has assigned decision-making to someone else, that person takes the place of the resident in exercising these rights.

What is a Resident or Family Council?

The new federal regulations specify that residents and families have the right to join together to:

- Discuss and offer suggestions about facility policies and procedures affecting residents' care, treatment, and quality of life;
- Support each other;
- Plan resident and family activities;
- · Participate in educational activities; or
- For any other purpose.

THE LAW

I. Resident & Family Councils [CFR 483.10(f)(5) F-565]

The resident has a right to organize and participate in resident groups in the facility.

- The facility must provide a resident or family group, if one exists, with private space; and take reasonable steps, with the approval of the group, to make residents and family members aware of upcoming meetings in a timely manner.
- The resident has a right to participate in family groups.
- The resident has a right to have family member(s) or other resident representative(s) meet in the facility with the families or resident representative(s) of other residents in the facility.

- Staff, visitors, or other guests may attend resident group or family group meetings only at the respective group's invitation.
- II. Facility Responsibilities for Resident & Family Councils
- The facility must provide a designated staff person who is approved by the resident or family
 group and the facility and who is responsible for providing assistance and responding to written
 requests that result from group meetings.
- The facility must consider the views of a resident or family group and act promptly upon the grievances and recommendations of such groups concerning issues of resident care and life in the facility.
 - o The facility must be able to demonstrate their response and rationale for such response.
 - This should not be construed to mean that the facility must implement as recommended every request of the resident or family group.

Considerations for Resident-Centered Advocacy

- Residents and families have the right to form and participate in a Council.
- Residents have the right to be a member of the Family Council and to decide if their family member or other designee participates in a Family Council.
- Nursing homes are required to provide a private space for Council meetings and can only
 have a staff person in attendance if he or she is invited by the Council.
- The nursing home must have a designated staff person who has been approved by the Council and is responsible for providing assistance to the Council and responding to written requests from the Council.
- Nursing homes must consider the Council's concerns and recommendations. While they are
 not obliged to do everything that the Council wants, nursing homes are required to
 demonstrate their response to the Council's concerns and recommendations and provide a
 rationale for their response.
- When the state surveyors come for an inspection they should be interviewing representatives from Resident and Family Councils to determine if these requirements are being fulfilled. For example, they should ask:
 - How are views, grievances or recommendations from the Council considered, addressed and acted upon? and
 - How do facility staff provide responses, actions, and rationales to the Council?


